BONDS (DELTA MARINE INDUSTRIES, INC. PROJECT) SERIES 2015A

Public notice is hereby given that on Thursday, December 1, 2022 at 10:00 a.m., Pacific time, or as soon thereafter as the matter may be heard, the Washington Economic Development Finance Authority of the State of Washington (the “Authority”) will hold a special hearing at the Authority’s offices located at 1000 Second Avenue, Suite 2700, Seattle, Washington and via Zoom: [www.zoom.us/join](http://www.zoom.us/join) or dial (253) 215-8782; Meeting ID: 842 2804 2963 / Passcode: 279252, for the purpose of receiving public comment regarding the proposed reissuance pursuant to Section 144(a) of the Internal Revenue Code of 1986, as amended (the “Code”) of its Variable Rate Economic Development Revenue Bonds (Delta Marine Industries, Inc. Project) Series 2015A (the “Bonds”) in an aggregate principal amount of \$10,000,000. The Bonds were issued for the purpose of refinancing the “Project” which consists of the acquisition, construction, and equipping of a yacht manufacturing and refit facility located at 1608 and 1745 South 96th Street, Seattle, in unincorporated King County. The Project is owned and operated by Delta Marine Industries, Inc. The Bonds will be deemed reissued under the Code as a result of proposed material changes in the terms of the Bonds. The payment of the principal of and interest on the Bonds does not constitute an obligation of the state of Washington or any political subdivision thereof, but is a special obligation of the Authority payable solely from the revenues provided for in the documents pursuant to which the Bonds were issued and reissued. The hearing will be a public meeting and will be conducted in a manner that provides reasonable opportunity for persons with differing views on both the reissuance of the Bonds and the proposed refinancing of the Project to be heard and to present their oral and written comments.
